ORDER

The Writ Petition has been filed to direct the respondent to grant permission to conduct cultural Programme (Adal Padal Nigalchi) in the event of Kukkalappalli Arulmighu Sri Ponniamman Koil at B.N. Palayam, K.V.Kuppam Taluk, Vellore District on 29.03.2023, at 6.00 P.M. to 11.00 P.M, by considering the petitioner's representation dated 07.02.2023.

2.The learned counsel appearing for the petitioner submitted that in order to conduct the cultural programme in the event of Kukkalappalli Arulmighu Sri Ponniamman Koil at B.N.
