ORDER

The prayer in the present writ petition is in two-fold. Firstly, the petitioner seeks for a direction to consider her representation, wherein, she sought for certain corrections in the digital entries of her patta. Secondly, she seeks for an injunction restraining the respondents not to disturb her peaceful possession and enjoyment of the property and also evicting her from the property in Survey No.16/5 and 17/1 situated at ponnarapatti Village, Valapadi Taluk, Salem.

2. Insofar as the first portion of the prayer is concerned, learned counsel for the petitioner submits that pursuant to the petitioner's representation, summons has been issued to the petitioner, calling upon her to appear before Tahsilar, Valapadi for an enquiry.

3. Since the respondents have initiated action pursuant to the petitioner's representation, the prayer for consideration of petitioner's representation does not deserve for consideration. It is always open to the

petitioner to participate in the enquiry and raise all her objections.

4. Insofar as the second prayer for restraining the respondents from evicting her from the suit property is concerned, the petitioner has already filed a civil suit in O.S.No.14 of 2021 before the District Munsif Court, Valapadi, seeking for similar relief. When the petitioner had already approached the civil court for the relief of injunction, the second portion of the prayer also does not deserve for consideration.

5. In the light of the above findings, the writ petition stands closed with liberty granted to the petitioner as above. No costs. Consequently, connected miscellaneous petitions are closed.
