**ORDER**

2.The learned counsel appearing for the petitioner submitted that in order to conduct the cultural programme in the event of Sri Mariamman Temple Festival, Senur Village, Senur Post, Katpadi Taluk, Vellore District, on 05.04.2023, the petitioner has sent a representation, dated 17.03.2023 to the respondent Police.
