ORDER

The Writ Petition has been filed to direct the respondent to grant permission to conduct cultural Programme (Adal Padal Nigalchi) in the event of “Sri Mahasakthi Ellamman Temple Festival” Mamarathupallam Village, Bedrahalli Post, Pennagaram Taluk, Dharmapuri District, on 27.03.2023, at 6.00 P.M. to 11.00 P.M, by considering the petitioner's representation dated 17.03.2023.

2.The learned counsel appearing for the petitioner submitted that in order to conduct the cultural programme in the event of “Sri Mahasakthi Ellamman Temple Festival” Mamarathupallam Village, Bedrahalli Post, Pennagaram Taluk, Dharmapuri District, on 27.03.2023, the petitioner has sent a representation, dated 17.03.2023 to the respondent Police.
