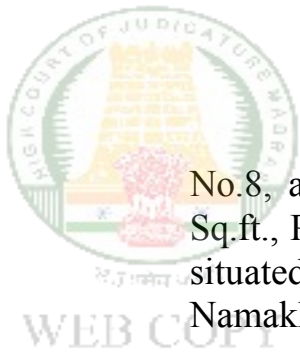

Prayer in WP No.41070 of 2015 : Writ Petition is filed under Article 226 of the Constitution of India, to issue a writ of Certiorarified Mandamus to call for the entire records of the first respondent relating to Sec. 4(1) Notification issued under Section 4(1) of the Tamilnadu Acquisition of Land for Harijan Welfare Schemes Act, 1978, in reference Number in ROC No.34994/2011, dated 18.04.2013, seeking acquisition of the petitioners Housing Plots situated at village No.68 of Vattur Village, comprised in S.No.7/3B2, admeasuring 1.28 Acres, situated at Tiruchengodu Taluk, Namakkal District,



to quash the same insofar as the petitioners' Lands are concerned and consequently, forebear the respondents from interfering with the peaceful possession and enjoyment of the petitioners Housing Plots (i.e) Plot No.20 & 24 admeasuring 3870 sq.ft. Plot No.6, admeasuring 1800 Sq.ft., Plot No.20 and 24 admeasuring 3870 Sq.ft.
