ORDER

The Writ Petition has been filed to direct the respondent to grant permission to conduct cultural Programme (Adal Padal Nigalchi) in the event of Kollampalayam Village Sri Dhurkali Amman Thirukovil at No.951-3rd Street, Kollampalayam Village, Pachampalayam Post, Erode District on 29.03.2023, at 6.00 P.M. to 11.00 P.M, by considering the petitioner's representation dated 16.03.2023.

2.The learned counsel appearing for the petitioner submitted that in order to conduct the cultural programme in the event of Kollampalayam Village Sri Dhurkali Amman Thirukovil at No.951-3rd Street, Kollampalayam Village, Pachampalayam Post, Erode District on 29.03.2023, the petitioner has sent a representation, dated 16.03.2023 to the respondent Police.
