ORDER

The Writ Petition has been filed to direct the respondent to grant permission to conduct cultural Programme (Adal Padal Nigalchi) in the event of Puthuvenkaraiyampalayam Arulmigu Sri Selva Vinayagar, Pattatharasiamman, Omsakthi Koil at Nathakadayur, Kittampalayam Post, Kangayam Taluk, Thirupur District on 28.03.2023, at 6.00 P.M. to 11.00 P.M, by considering the petitioner's representation dated 07.03.2023.

2.The learned counsel appearing for the petitioner submitted that in order to conduct the cultural programme in the event of Puthuvenkaraiyampalayam Arulmigu Sri Selva Vinayagar, Pattatharasiamman, Omsakthi Koil at Nathakadayur, Kittampalayam Post, Kangayam Taluk, Thirupur District on 28.03.2023, the petitioner has sent a representation, dated 07.03.2023 to the respondent Police. But, the same has not been considered so far. Hence, the present writ petition has been filed.

3.The learned Government Advocate (Criminal side) appearing for the respondents submitted that the respondent police has received the

Therefore, in view of the detailed circular and guidelines issued by the Director General of Police, the respondent police is hereby directed to consider the representation of the petitioner, dated 07.03.2023 and pass suitable orders based on the above said circular.

6. With the above direction, this Writ Petition is disposed of. No costs.
