This Writ Petition has been filed to direct the respondent to grant permission and police protection to conduct the Cultural event viz., Adal Padal (Song and Dance) program to be held on 05.04.2023 between 6.00 p.m to 11.00 pm, subsequently grant permission to erect cone type speaker from 03.04.2023 to 06.04.2023 in connection with the Temple Festival of Denkanikottai Arulmigu Sree Petraya Swamy Temple Brammorchavam Festival at Krishnagiri District by considering the petitioner's representation dated 14.03.2023.

2.The learned counsel appearing for the petitioner submitted that in order to conduct the cultural programme in the event of Denkanikottai Arulmigu Sree Petraya Swamy Temple Brammorchavam Festival at Krishnagiri District on 05.04.2023 between 6.00 pm to 11.00 pm, the petitioner has sent a representation dated 14.03.2023 to the respondent. But, the same has not been considered so far. Hence, the present writ petition has been filed.

It is brought to the notice of this Court that the Director General of Police, Tamil Nadu, Chennai, had issued a Circular Memorandum in Rc.007301/Genl.I(1)/2019, dated 09.04.2019, along with instructions to the Inspectors of Police throughout Tamil Nadu for consideration of applications seeking permission for conducting cultural programme. Therefore, in view of the detailed circular and guidelines issued by the Director General of Police, the respondent police is hereby directed to consider the representation of the petitioner, dated 14.03.2023 and pass suitable orders based on the above said circular.

6. With the above direction, this Writ Petition is disposed of. No costs.
