ORDER

This Writ Petition has been filed to direct the respondent to give permission and police protection to conduct Cultural Programme (Adal Padal Nigalchi) in the event of Mallasamuthiram Melmugam Village, Athappampatti Arulmigu Sree Maha Mariyamman Temple Festival at Tiruchengode Taluk, Namakkal District on 07.04.2023 between 06.00 PM to 11.00 PM by considering the petitioner's representation dated 18.03.2023.

2.The learned counsel appearing for the petitioner submitted that in order to conduct the cultural programme in the event of Mallasamuthiram Melmugam Village, Athappampatti Arulmigu Sree Maha Mariyamman Temple Festival at Tiruchengode Taluk, Namakkal District on 07.04.2023 between 06.00 PM to 11.00 PM, the petitioner has sent a representation dated 18.03.2023 to the respondent. But, the same has not been considered so far. Hence, the present writ petition has been filed.

3.The learned Government Advocate (Crl.side) appearing for the respondent submitted that the respondent police has received the representation of the petitioner and the same is pending for consideration.
