This Court by its order dated 13.07.2023 directed the Registry to send hearing notice informing the party-in-person that the matter will be taken for disposal on 24.07.2023. Subsequently, this Court has directed the Registry to sent a fresh notice to the party-in-person and adjourned the case to 28.08.2023.

2. When the matter was taken up for hearing on 28.08.2023, fresh notice which has been sent to the party-in-person came with an endorsement “service awaited”. Again the matter was listed on 12.09.2023, however, the party-in-person has not appeared before this Court. When the matter was taken up for hearing on 05.10.2023, there was no representation on behalf of the party-in-person. Hence, Registry was directed to list the case on 13.10.2023 under the caption “For Dismissal”.
