This Writ Petition has been filed to direct the respondent to grant permission and police protection to conduct the Cultural programme (Adal Padal Nigalchi) to be held on 06.04.2023 between 6.00 p.m to 11.00 pm in the event of Sivammalai Arulmigu Sree Mariyamman & Veerakaliyamman Temple Festival at Kangeyam Taluk, Tiruppur District by considering the petitioner's representation dated 20.03.2023.

Therefore, in view of the detailed circular and guidelines issued by the Director General of Police, the respondent police is hereby directed to consider the representation of the petitioner, dated 20.03.2023 and pass suitable orders based on the above said circular.

6. With the above direction, this Writ Petition is disposed of. No costs.
