ORDER

This Writ Petition has been filed to direct the respondent to give permission and police protection to conduct Cultural Programme (Adal Padal Nigalchi) in the event of Navani Pallipatti Village Arulmigu Sree Maha Mariyamman Temple Festival at Namakkal Taluk & District on 03.04.2023 between 06.00 PM to 11.00 PM by considering the petitioner's representation dated 20.03.2023.

2.The learned counsel appearing for the petitioner submitted that in order to conduct the cultural programme in the event of Navani Pallipatti Village Arulmigu Sree Maha Mariyamman Temple Festival at Namakkal Taluk & District on 03.04.2023 between 06.00 PM to 11.00 PM, the petitioner has sent a representation dated 20.03.2023 to the respondent.
