This Writ Petition has been filed to direct the respondent to give permission to conduct Cultural programme (Adal Padal Nigalchi) in the event of Kanakkupatti Village Arulmigu Sree Kappathuval Mariyamman Temple Festival at Omalur Taluk, Salem District to be held on 04.04.2023 between 6.00 pm to 11.pm by considering the petitioner's representation dated 21.03.2023.

Therefore, in view of the detailed circular and guidelines issued by the Director General of Police, the respondent police is hereby directed to consider the representation of the petitioner, dated 21.03.2023 and pass suitable orders based on the above said circular.
