ORDER

The Writ Petition has been filed to direct the respondents to grant permission to conduct cultural Programme (Adal Padal Nigalchi) in the event of Sri Subramani Temple Festival, Sennampatti village, A.Sappanipatti Post, Karimangalam Taluk, Dharmapuri District, on 06.04.2023 at 6.00 P.M. to 11.00 P.M, by considering the petitioner's representation dated 20.03.2023.

2.The learned counsel appearing for the petitioner submitted that in order to conduct the cultural programme in the event of Sri Subramani Temple Festival, Sennampatti village, A.Sappanipatti Post, Karimangalam Taluk, Dharmapuri District, on 06.04.2023, the petitioner has sent a representation, dated 20.03.2023 to the respondent Police. But, the same has not been considered so far. Hence, the present writ petition has been filed.
