ORDER

The Writ Petition has been filed to direct the respondent to grant permission to conduct cultural Programme (Adal Padal Nigalchi) in the event of “Sri Kodhandaramar Temple Ramanavami Urchava festival” Venkattampatti Village, Venkattampatti Post, Nallampalli Taluk, Dharmapuri District, on 05.04.2023, at 6.00 P.M. to 11.00 P.M, by considering the petitioner's representation dated 20.03.2023.

2.The learned counsel appearing for the petitioner submitted that in order to conduct the cultural programme in the event of “Sri Kodhandaramar Temple Ramanavami Urchava festival” Venkattampatti Village, Venkattampatti Post, Nallampalli Taluk, Dharmapuri District, on 05.04.2023, the petitioner has sent a representation, dated 20.03.2023 to the respondent Police.
