2. Mr.R.Palani, Sub Inspector of Police, B1, Town Police Station, Tiruvallur is present before this Court.

3. The petitioner herein, earlier filed CrI.O.P.No.18090 of 2021 before this Court, seeking a direction to direct B1, Town Police station, Tiruvallur to investigate and file a final report in Crime No.261 of 2019, this Court by order dated 05.10.2021 directed the police to complete the investigation and final a report within a period of two months. Thereafter, no action has been taken. Hence, the above contempt petition has been filed.

2. Learned Additional Public Prosecutor appearing for the respondent submitted that in this case investigation has been completed. There are totally four accused in this case, who are facing charge for the
