The learned counsel appearing for the petitioner submitted that in order to conduct the cultural programme in the event of Thasanaickanpatti @ Kullagoundanur Arulmigu Sree Mariyamman Temple Festival at Salem Taluk & District on 29.03.2023 between 06:00 pm to 11:00 pm, the petitioner has sent a representation dated 22.03.2023 to the respondents. But, the same has not been considered so far. Hence, the present writ petition has been filed.

3. The learned Government Advocate (Crl.side) appearing for the respondent submitted that the respondent police has received the representation of the petitioner and the same is pending for consideration.
