ORDER

The Writ Petition has been filed to direct the respondent to grant permission to conduct cultural Programme (Adal Padal Nigalchi) in the event of Pungankattur Village Arulmigu Sree Sakthi Mariyamman Temple Festival at Gobi Taluk, Erode District on 01.04.2023, at 6.00 P.M. to 11.00 P.M, by considering the petitioner's representation dated 21.03.2023.

2.The learned counsel appearing for the petitioner submitted that in order to conduct the cultural programme in the event of event of Pungankattur Village Arulmigu Sree Sakthi Mariyamman Temple Festival at Gobi Taluk, Erode District on 01.04.2023, the petitioner has sent a representation, dated 21.03.2023 to the respondent Police.
