The Writ Petition has been filed to direct the respondent to give permission and police protection to conduct cultural programme of (Adal

Padal Nigalchi) in the event of Korathupatti Village Arulmigu Sree Selva Mariyamman Temple Festival at Salem Takuk and District on 31.03.2023 between 06:00 pm to 11:00 pm by considering the petitioner's representation dated 21.03.2023.

The learned counsel appearing for the petitioner submitted that in order to conduct the cultural programme in the event of Korathupatti Village Arulmigu Sree Selva Mariyamman Temple Festival at Salem Takuk and District on 31.03.2023 between 06:00 pm to 11:00 pm, the petitioner has sent a representation dated 21.03.2023 to the respondents. But, the same has not been considered so far. Hence, the present writ petition has been filed.

It is brought to the notice of this Court that the Director General of Police, Tamil Nadu, Chennai, had issued a Circular Memorandum in Rc.007301/Genl.I(1)/2019, dated 09.04.2019, along with instructions to the Inspectors of Police throughout Tamil Nadu for consideration of applications seeking permission for conducting cultural programme. Therefore, in view of the detailed circular and guidelines issued by the Director General of Police, the respondent police is hereby directed to consider the representation of the petitioner, dated 21.03.2023 and pass suitable orders based on the above said circular.
