ORDER

The Writ Petition has been filed to direct the respondent to grant permission to conduct cultural Programme (Adal Padal Nigalchi) in the event of Kannurpatti Village Arulmigu Sree Mariyamman Temple Festival at Namakkal Taluk & District on 05.04.2023, at 6.00 P.M. to 11.00 P.M, by considering the petitioner's representation dated 22.03.2023.

2.The learned counsel appearing for the petitioner submitted that in order to conduct the cultural programme in the event of Kannurpatti Village Arulmigu Sree Mariyamman Temple Festival at Namakkal Taluk & District on 05.04.2023, the petitioner has sent a representation, dated 22.03.2023 to the respondent Police. But, the same has not been considered so far. Hence, the present writ petition has been filed.
