ORDER

The Writ Petition has been filed to direct the respondent to grant permission to conduct cultural Programme (Adal Padal Nigalchi) in the event of Pullagoundampatti Village Arulmigu Sree Mariyamman Temple Festival at Sangakiri Taluk, Salem District on 08.04.2023, at 6.00 P.M. to 11.00 P.M, by considering the petitioner's representation dated 22.03.2023.

2.The learned counsel appearing for the petitioner submitted that in order to conduct the cultural programme in the event of Pullagoundampatti Village Arulmigu Sree Mariyamman Temple Festival at Sangakiri Taluk, Salem District on 08.04.2023, the petitioner has sent a representation, dated 22.03.2023 to the respondent Police. But, the same has not been considered so far. Hence, the present writ petition has been filed.
