The Writ Petition has been filed to direct the respondent to grant permission to conduct cultural Programme (Adal Padal Nigalchi) in the event of Poondurai Semur Village Arulmigu Sree Makaliyamman Temple Festival at Modakurichi Taluk, Erode District on 13.04.2023, at 6.00 P.M. to 11.00 P.M., by considering the petitioner's representation dated 21.03.2023.

2.The learned counsel appearing for the petitioner submitted that in order to conduct the cultural programme in the event of Poondurai Semur Village Arulmigu Sree Makaliyamman Temple Festival at Modakurichi Taluk, Erode District on 13.04.2023, the petitioner has sent a representation, dated 21.03.2023 to the respondent Police. But, the same has not been considered so far. Hence, the present writ petition has been filed.
