ORDER

This Writ Petition has been filed to direct the respondent to give permission and police protection to conduct cultural programme (Adal Padal Nigalchi) in the event of Kondakinthanapalli, Thangamalai Adivaram Village, Arulmigu Sri Chendryaya Swamy Temple Saina Urchavam, Vishvarooob Darshan, Thirumanjanam Festival at Natrampalli Taluk, Tirupattur District on 08.04.2023 and 09.04.2023 between 06.00 PM to 11.00 PM by considering the petitioner's representation dated 06.03.2023.

The learned counsel appearing for the petitioner submitted that in order to conduct the cultural programme in the event of ***Kondakinthanapalli, Thangamalai Adivaram Village, Arulmigu Sri Chendryaya Swamy Temple Saina Urchavam, Vishvarooob Darshan, Thirumanjanam Festival at Natrampalli Taluk, Tirupattur District on 08.04.2023 and 09.04.2023, between 06.00 P.M and 11.00 P.M, the***

Therefore, in view of the detailed circular and guidelines issued by the Director General of Police, the respondent police is hereby directed to consider the representation of the petitioner, dated **06.03.2023** and pass
