The Writ Petition has been filed for directing the first and second respondents to grant permission to conduct the cultural programme of Adal Padal on 14.04.2023 at 06.00 PM to 11.00 PM at “Sri Chamundeeswari Amman Temple festival” Eripattarai Village, Agravaram Post, Gudiyatham Taluk, Vellore District by consider and pass orders on the representation dated 24.03.2023 made by the petitioner within the time frame as may be fixed by this Honorable Court.

2.The learned counsel appearing for the petitioner submitted that in order to conduct the cultural programme in the event of “Sri Chamundeeswari Amman Temple festival” Eripattarai Village, Agravaram Post, Gudiyatham Taluk, Vellore District on 14.04.2023 between 6 PM to 11 PM, the petitioner has sent a representation dated 24.03.2023 to the respondent. But, the same has not been considered so far. Hence, the present writ petition has been filed.

3.The learned Government Advocate (Crl.side) appearing for the respondent submitted that the respondent police has received the representation of the petitioner and the same is pending for consideration.
