The Writ Petition has been filed for directing the respondent to grant permission and police protection to conduct the cultural event viz. Adal Padal (Song and Dance) program to be held on 08.04.2023 at 6.00 pm onwards in connection with the Temple Festival of Arulmigu Sri Mariamman and Sri Kaliamman Temple, Puthur Village, Salem Taluk, Salem District by considering the petitioners representation dated 25.03.2023.

2.The learned counsel appearing for the petitioner submitted that in order to conduct the cultural programme in the event of Arulmigu Sri Mariamman and Sri Kaliamman Temple, Puthur Village, Salem Taluk, Salem District on 08.04.2023 between 6 PM to 11 PM, the petitioner has sent a representation dated 25.03.2023 to the respondent. But, the same has not been considered so far. Hence, the present writ petition has been filed.
