ORDER

(This case has been heard through Video Conferencing)

The petitioner, who was arrested and remanded to judicial custody on 25.11.2022, for the offences punishable under Sections 8(c) r/w 20(b)(ii)(B) & 29(1) of Narcotic Drugs and Psychotropic Substances Act, 1985, in Crime No.950 of 2022, on the file of the respondent police, seeks bail.

2. The case of the prosecution is that on receipt of the secret information about illegal transport of Narcotic substance, the respondent and his team conducted a check up, during which, they found that the accused were in illegal possession of 2 kilograms of Ganja. Hence the case.

3. Learned counsel appearing for the petitioner submitted that the petitioner is an innocent person and he has been falsely implicated in this case, since he has got some previous cases. He further submitted that even as per the prosecution, the contraband alleged to have been recovered from the petitioner is an intermediate quantity. He also submitted that investigation in this case has been completed and the case has also been committed in

C.C.No.182 of 2023 on the file of the Principal Special Court under EC & NDPS Act, Chennai. He also submitted the petitioner is in custody from 25.11.2022, hence, he prayed for grant of bail to the petitioner.

4. The respondent has filed the detailed counter.

5. Learned Government Advocate (Crl.Side) appearing for the respondent police opposed for granting bail to the petitioner stating that the petitioner is habitual offender and a history sheeted 'B' Category Rowdy vide H.S.No.39 of 2020, against whom, 5 previous cases are pending, out of which, one case is of similar in nature. He further submitted that as far as this case is concerned, the petitioner along with other accused was found to be in illegal possession of 2 kilograms of Ganja. He also submitted that the case has been taken up on the file of the Principal Special Court under EC & NDPS Act, Chennai, in C.C.No.182 of 2023 and the case now stands posted on 10.05.2023 for appearance of the accused. Hence, he prayed for dismissal of the petition.

6. At this juncture, the learned counsel for the petitioner submitted that the petitioner, without prejudice to his defence and contention, is ready and willing to deposit an amount of Rs.20,000/- to any welfare scheme run by the Government. He further stated that the petitioner is also ready to abide by any other stringent conditions that may be imposed by this Court. Hence, he prays for grant of bail to the petitioner.

7. Heard the learned Counsel for the petitioner and the learned Government Advocate (CrI.Side) and perused the materials available on record.

8. On considering the voluntary submission made by the learned counsel for the petitioner, the petitioner is directed to deposit a sum of Rs.20,000/- (Rupees Twenty Thousand only) to the credit of "MANASU", without prejudice to his rights and contentions before the trial Court.

9. Merely, because the petitioner has deposited the said amount, it would not amount to admission of his guilt. Therefore, it is open to the trial Court to deal with the case independently.

10. Taking into consideration the facts and circumstances of the case, the submissions made by the learned counsel on either side and also taking note of the fact that the petitioner has come forward to deposit an amount of Rs.20,000/- to the credit of "MANASU", this Court is inclined to grant bail to the petitioner with certain conditions.

11. Accordingly, the petitioner is ordered to be released on bail on condition to make a non-refundable deposit of Rs.20,000/- (Rupees Twenty Thousand only) by way of **RTGS/NEFT to the credit of "MANASU, CSB Bank, Pallavaram Branch, A/C.No.024404406764190001, IFSC : CSBK0000244"**, without prejudice to his rights and contentions before the trial Court, on such deposit and production of proof, the petitioner is ordered to be released on bail on his executing a bond for a sum of **Rs.25,000/- (Rupees Twenty five thousand only)** with **two sureties**, for a like sum to the satisfaction of the **learned Judicial Magistrate-II, Ponneri**, and on further conditions that:

[a] the sureties shall affix their photographs and

Magistrate may obtain a copy of their Aadhar card or Bank pass Book to ensure their identity;

[b] the petitioner shall appear before the Principal Special Court under EC & NDPS Act, Chennai, on all working days at 10.30 a.m., until further orders;

[c] the petitioner shall not abscond during trial;

[d] the petitioner shall not tamper with evidence or witness during trial;

[e] On breach of any of the aforesaid conditions, the learned Magistrate/Trial Court is entitled to take appropriate action against the petitioner in accordance with law as if the conditions have been imposed and the petitioner released on bail by the learned Magistrate/Trial Court himself as laid down by the Hon'ble Supreme Court in *P.K.Shaji vs. State of Kerala [(2005)AIR SCW 5560]*;

[f] If the accused thereafter abscond, a fresh FIR can be registered under Section 229A IPC.
