ORDER

This Writ Petition has been filed to direct the respondent to grant permission and police protection to conduct cultural programme (Adal Padal Nigalchi) in the event of Rasathupuram (Melvisharam) Arulmigu Sree Mariyamman Temple Festival at Walajah Taluk, Ranipettai District on 01.04.2023 between 06.00 P.M to 11.00 P.M by considering the petitioner's representation dated 24.03.2023.

Therefore, in view of the detailed circular and guidelines issued by the Director General of Police, the respondent police is hereby directed to consider the representation of the petitioner, dated **24.03.2023** and pass suitable orders based on the above said circular.
