ORDER

This Writ Petition has been filed to direct the respondent to give permission and police protection to conduct cultural programme (Adal Padal Nigalchi) in the event of S.Ogaiyur Village, Manthaiveli Arulmigu Sree Annakodi Madavalayam Swamy Temple Festival at Kallakurichi Taluk & District on 19.04.2023 between 06.00 PM to 11.00 PM by considering the petitioner's representation dated 25.03.2023.

Therefore, in view of the detailed circular and guidelines issued by the Director General of Police, the respondent police is hereby directed to consider the representation of the petitioner, dated **25.03.2023** and pass suitable orders based on the above said circular.
