The Writ Petition has been filed for directing the respondent to give permission and police protection to conduct Cultural programme (Adal Padal Nigalchi) in the event of Thurusanampalayam Village Arulmigu Sree Jederudra Swamy Temple Festival at Anthiyur Taluk, Erode District on 11.04.2023 between 06.00PM to 11.00PM by considering the petitioner's representation dated 25.03.2023.

2.The learned counsel appearing for the petitioner submitted that in order to conduct the cultural programme in the event of Thurusanampalayam Village Arulmigu Sree Jederudra Swamy Temple Festival at Anthiyur Taluk, Erode District on 11.04.2023 between 6 PM to 11 PM, the petitioner has sent a representation dated 25.03.2023 to the respondent. But, the same has not been considered so far. Hence, the present writ petition has been filed.

3.The learned Government Advocate (Crl.side) appearing for the respondent submitted that the respondent police has received the representation of the petitioner and the same is pending for consideration.
