praying to issue a Writ of Certiorarified Mandamus to call for the records relevant to the order in Na.Ka.No.31252/2012/A4 dated 24.11.2014 passed by the first respondent and quash the same as illegal, improper against the law and thereby direct the first respondent to reinstate the petitioner into his service in the post of Junior Assistant in the fifth respondent Department with effect from 18.07.2014 and pay all back wages and other service benefits to the petitioner.
