ORDER

This Writ Petition has been filed to direct the respondent to grant permission and police protection to conduct cultural programme (Adal Padal Nigalchi) in the event of Thillaivilagam Village Arulmigu Sree Veera Kothandarama Swamy & Ramanavami Temple Festival at Thiruthuraipoondi Taluk, Tiruvarur District on 04.04.2023 between 06.00 P.M to 11.00 P.M by considering the petitioner's representation dated 23.03.2023.

The learned counsel appearing for the petitioner submitted that in order to conduct the cultural programme in the event of *Thillaivilagam Village Arulmigu Sree Veera Kothandarama Swamy & Ramanavami Temple Festival at Thiruthuraipoondi Taluk, Tiruvarur District on 04.04.2023 between 06.00 P.M and 11.00 P.M, the petitioner has sent a representation dated 23.03.2023* to the respondent. But, the same has not been considered so far. Hence, the present writ petition has been filed.

Therefore, in view of the detailed circular and guidelines issued by the Director General of Police, the respondent police is hereby directed to consider the representation of the petitioner, dated **23.03.2023** and pass suitable orders based on the above said circular.
