ORDER

This Writ Petition has been filed to direct the respondent authority to give Bandhobasth and permission for conducting the cultural dance program (Adal Padal) in the event of B.P.Agarakaram Village Sri Kannimaar Amman Thirukovil at Annai Sathiya Nagar, B.P.Agarakaram Village & Post, Erode District on 05.04.2023 between 6 PM to 11 PM based on the petitioner representation dated 18.03.2023.

The learned counsel appearing for the petitioner submitted that in order to conduct the cultural programme in the event of ***B.P.Agarakaram Village Sri Kannimaar Amman Thirukovil at Annai Sathiya Nagar, B.P.Agarakaram Village & Post, Erode District on 05.04.2023, between 06.00 P.M and 11.00 P.M, the petitioner has sent a representation dated 18.03.2023*** to the respondent. Therefore, in view of the detailed circular and guidelines issued by the Director General of Police, the respondent police is hereby directed to consider the representation of the petitioner, dated **18.03.2023** and pass suitable orders based on the above said circular.
