ORDER

This Writ Petition has been filed to direct the respondent authority to give Bandhobasth and permission for conducting the cultural dance program (Adal Padal) in the event of Eraiyamangalam Village Sri Chinna Mariamman Thirukovil at, Korakuttai, Eraiyamangalam Village, A-Eraiyamangalam Post, Thiruchengode Taluk, Namakkal District on 06.04.2023 between 6 PM to 11 PM based on the petitioner representation dated 27.03.2023.

The learned counsel appearing for the petitioner submitted that in order to conduct the cultural programme in the event of ***Eraiyamangalam Village Sri Chinna Mariamman Thirukovil at, Korakuttai, Eraiyamangalam Village, A-Eraiyamangalam Post, Thiruchengode Taluk, Namakkal District on 06.04.2023, between 06.00 P.M and 11.00 P.M, the petitioner has sent a representation dated 27.03.2023*** to the respondent. It is brought to the notice of this Court that the Director General of Police, Tamil Nadu, Chennai, had issued a Circular Memorandum in Rc.007301/Genl.I(1)/2019, dated 09.04.2019, along with instructions to the Inspectors of Police throughout Tamil Nadu for consideration of applications seeking permission for conducting cultural programme. Therefore, in view of the detailed circular and guidelines issued by the Director General of Police, the respondent police is hereby directed to consider the representation of the petitioner, dated **27.03.2023** and pass suitable orders based on the above said circular.

6. With the above direction, this Writ Petition is Allowed. No costs.
