This Writ Petition has been filed directing the respondent to give for permission to conduct Cultural programme (Adal Padal Nigalchi) in the event of Eriethuvai Taluk, Sri Kundi Mariamman Koil at Agraharam, Natrampalli,

Velur District on 05.04.2023 between 6 PM to 11 PM based on the petitioner's representation dated 07.03.2023.

2.The learned counsel appearing for the petitioner submitted that in order to conduct the cultural programme in the event of Eriethuvai Taluk, Sri Kundi Mariamman Koil at Agraharam, Natrampalli, Velur District on 05.04.2023 between 06.00 PM to 11.00 PM, the petitioner has sent a representation dated 07.03.2023 to the respondent. But, the same has not been considered so far. Hence, the present writ petition has been filed.
