ORDER

The Writ Petition has been filed to direct the respondent to grant permission to conduct cultural Programme (Adal Padal Nigalchi) in the event of Arulmighu Sri Maha Sakthi Mariamman Koil at Manickampalayam, Periya Semur Post, Erode District on 07.04.2023, at 6.00 P.M. to 11.00 P.M, by considering the petitioner's representation dated 07.03.2023.

2.The learned counsel appearing for the petitioner submitted that in order to conduct the cultural programme in the event of Arulmighu Sri Maha Sakthi Mariamman Koil at Manickampalayam, Periya Semur Post, Erode District on 07.04.2023, the petitioner has sent a representation, dated 07.03.2023 to the respondent Police. But, the same has not been considered so far. Hence, the present writ petition has been filed.
