by considering the petitioner's representation dated 25.03.2023.

The learned counsel appearing for the petitioner submitted that in order to conduct the cultural programme in the event of Malaikottalam Village Arulmigu Sree Pillaiyar Swamy Temple Festival at Kallakurichi Taluk and District on 04.04.2023 between 06.00 PM to 11.00 PM, the petitioner has sent a representation dated 25.03.2023 to the respondent. Therefore, in view of the detailed circular and guidelines issued by the Director General of Police, the respondent police is hereby directed to consider the representation of the petitioner, dated 25.03.2023 and pass suitable orders based on the above said circular.

6. With the above direction, this Writ Petition is disposed of. No costs.
