ORDER

This Writ Petition has been filed to direct the respondent to give permission and police protection to conduct cultural programme (Adal Padal Nigalchi) in the event of Kottavadi Village Arulmigu Sree Maha Sakthi Mariyamman & Selliyamman Temple Festival at P.N.Palayam Taluk, Salem District on 27.04.2023 & 28.04.2023 between 06.00 PM to 11.00 PM by considering the petitioner's representation dated 22.03.2023.

The learned counsel appearing for the petitioner submitted that in order to conduct the cultural programme in the event of ***Kottavadi Village Arulmigu Sree Maha Sakthi Mariyamman & Selliyamman Temple Festival at P.N.Palayam Taluk, Salem District on 27.04.2023 and 28.04.2023 between 06.00 P.M and 11.00 P.M, the petitioner has sent a representation dated 22.03.2023*** to the respondent. Therefore, in view of the detailed circular and guidelines issued by the Director General of Police, the respondent police is hereby directed to consider the representation of the petitioner, dated **22.03.2023** and pass suitable orders based on the above said circular.
