ORDER

This Writ Petition has been filed to direct the respondent to give permission to conduct cultural programme (Adal Padal Nigalchi) in the event of Perakkarainadu, Oorpuram Arulmigu Sree Periya Mariyamman Temple Festival at Kolli Hills Taluk, Namakkal District on 02.05.2023 between 06.00 PM to 11.00 PM by considering the petitioner's representation dated 27.03.2023.
