ORDER

The Writ Petition has been filed to direct the respondent to grant permission to conduct cultural Programme (Adal Padal Nigalchi) in the event of Chinnaparuvachi Village Sri Mari Amman Thirukovil at Chinnaparuvachi Village Sempulichampalayam Anthiyur Erode District on 8.04.2023 at 6.00 PM to 11.00 PM by considering the petitioner's representation dated 30.03.2023.

2.The learned counsel appearing for the petitioner submitted that in order to conduct the cultural programme in the event of Chinnaparuvachi Village Sri Mari Amman Thirukovil at Chinnaparuvachi Village Sempulichampalayam Anthiyur Erode District on 8.04.2023, the petitioner has sent a representation, dated 30.03.2023 to the respondent Police. But, the same has not been considered so far. Hence, the present writ petition has been filed.

3.The learned Government Advocate (Criminal side) appearing for the respondents submitted that the respondent police has received the representation of the petitioner and the same is pending for consideration.
