PRAYER: Writ Petition filed under Article 226 of the Constitution of India, to issue a Writ of Certiorarified Mandamus or any other writ, order or direction in the nature of writ calling for the records relating to the proceedings of the 3rd respondent to disconnect and remove the electricity service connections in SC Nos.053-003-89 & 053-003-689 given and installed in existence in the petitioner's land in SF No.31/3, Sulus Village, Coimbatore in the name of 4th respondent.

ORDER

This Writ Petition has been filed for quashment of the impugned proceedings dated 31.05.2018 which was passed by the 3rd respondent and for a direction to the 3rd respondent to disconnect the electricity service connections in the petitioner's land, which stands in the name of the 4th respondent.
