This Writ Petition has been filed directing the first and second respondents to grant permission to conduct the Cultural programme of Adal Padal on 07.04.2023 at 06.00 P.M. to 11.00 P.M at “Sri Mariamman Temple Festival” Perumpalai Village, Perumpalai Post, Pennagaram Taluk, Dharmapuri District by consider and pass orders on the representation dated 28.03.2023 made by the petitioner within the time frame as may be fixed by this Honourable Court.

The learned counsel appearing for the petitioner submitted that in order to conduct the cultural programme in the event of “Sri Mariamman Temple Festival” Perumpalai Village, Perumpalai Post, Pennagaram Taluk, Dharmapuri District on 07.04.2023 between 06.00 PM to 11.00 PM, the petitioner has sent a representation dated 28.03.2023 to the respondent. Therefore, in view of the detailed circular and guidelines issued by the Director General of Police, the respondent police is hereby directed to consider the representation of the petitioner, dated 28.03.2023 and pass suitable orders based on the above said circular.

6. With the above direction, this Writ Petition is disposed of. No costs.
