ORDER

This Writ Petition has been filed to direct the respondent to grant permission and police protection to conduct the cultural programme (Adal Padal Nigalchi) in the event of Pallipatti Village Arulmigu Sree Veda Mariyamman Temple Festival at Mettur Taluk, Salem District on 12.04.2023 between 06.00 PM to 11.00 PM by considering the petitioner's representation dated 30.03.2023.

Therefore, in view of the detailed circular and guidelines issued by the Director General of Police, the respondent police is hereby directed to consider the representation of the petitioner, dated **30.03.2023** and pass suitable orders based on the above said circular.
