The learned counsel appearing for the petitioner submitted that in order to conduct the cultural programme in the event of Vasur Village Arulmigu Sree Gangaiyamman Temple Festival at Walajah Taluk, Ranipettai District on 08.05.2023 at 06.00 PM to 11.00 PM, the petitioner has sent a representation dated 28.03.2023 to the respondent, but, the same has not been considered so far. Therefore, in view of the detailed circular and guidelines issued by the Director General of Police, the respondent police is hereby directed to consider the representation of the petitioner, dated 28.03.2023 and pass suitable orders based on the above said circular.
