3.Since the Suit for partition is pending between the petitioners and the private respondents herein in O.S. No.431 of 2012 before the I Additional Subordinate Judge, Coimbatore, in which, the petitioners have also made an Application to implead the official respondents herein as defendants in the Suit, it would be appropriate that the present prayer seeking for direction can also be made before the concerned Civil Court.

4.In view of such an alternate remedy available, the prayer in the present writ petition does not deserve consideration.

5.The learned I Additional Subordinate Judge, Coimbatore is called upon to dispose of the petitioners' Application in I.A. No.6 of 2023 as expeditiously as possible, in any event, within a period of three months from the date of receipt of a copy of this order.

6.The petitioner is at liberty to seek for an injunction, sought for in the present writ petition before the concerned Civil Court, which Application shall also be decided expeditiously.
