ORDER

This Writ Petition has been filed to direct the respondent to grant permission and police protection to conduct the cultural event viz., Adal Padal (Song and Dance) program to be held on 12.04.2023 at 06.00 PM onwards in connection with the Temple Festival of Danish Pettai Arulmigu Sri Mariamman Temple, Kanchi Nagar Village, Kadaiyambatti Taluk, Salem District by considering the petitioner's representation dated 03.04.2023.

Therefore, in view of the detailed circular and guidelines issued by the Director General of Police, the respondent police is hereby directed to consider the representation of the petitioner, dated **03.04.2023** and pass suitable orders based on the above said circular.
