ORDER

This Writ Petition has been filed to direct the respondent to give for permission to conduct the cultural programme (Adal Padal Nigalchi) in the event of Kakkathoppu Village Arulmigu Sri Kaliamman Koil Melmuttukur, Gudiyatham Taluk, Vellore District on 15.04.2023 between 06.00 PM to 11.00 PM by considering the petitioner's representation dated 07.03.2023.

Therefore, in view of the detailed circular and guidelines issued by the Director General of Police, the respondent police is hereby directed to consider the representation of the petitioner, dated **07.03.2023** and pass suitable orders based on the above said circular.
