### **ORDER**

2. The Respondent is the tenant and the Revision petitioners are land lords and there was dispute between them. The tenancy dispute has already been dealt with in C.R.P.No.3749 of 2019 and C.M.P.No.24627 of 2019 and this Court vide order dated 20.11.2019 directed the respondent to vacate the premises on or before 02.01.2020.
