ORDER

The Writ Petition has been filed to direct the respondent to grant permission to conduct cultural Programme (Adal Padal Nigalchi) in the event of Sithalur Village Arulmigu Sree Murugan Swamy Temple Festival at Thiyagaduruvam Taluk, Kallkurichi District, on 11.04.2023, at 6.00 P.M. to 11.00 P.M, by considering the petitioner's representation dated 03.04.2023.

2.The learned counsel appearing for the petitioner submitted that in order to conduct the cultural programme in the event of Sithalur Village Arulmigu Sree Murugan Swamy Temple Festival at Thiyagaduruvam Taluk, Kallkurichi District, on 11.04.2023, the petitioner has sent a representation, dated 03.04.2023 to the respondent Police. But, the same has not been considered so far. Hence, the present writ petition has been filed.
