ORDER

This Criminal Original Petition is filed to transfer the investigation in Crime No.92 of 2023 pending on the file of the 3rd respondent to the 4th respondent (CB-CID).

2.The learned counsel appearing for the petitioner submitted that the 3rd respondent had not conducted the investigation in an effective manner. He would further submit that though the petitioner had suffered grievous injuries, the First Information Report was registered only for the offences under Sections 294(b), 354, 324, 342 & 323 of IPC.

3.The learned Government Advocate (Crl. Side) appearing for the respondents would submit that during investigation, if they find that other offences are made out, they would file an alternation

report.
