ORDER

This Writ Petition has been filed to direct the respondent to give permission to conduct cultural programme (Adal Padal Nigalchi) in the event of Mukkanur Village Arulmigu Sree Pattanathu Mariyamman Temple Festival at Natrampalli Taluk, Tirupathur District on 06.05.2023 between 06.00 PM to 11.00 PM by considering the petitioner's representation dated 03.04.2023.
